
Overcoming distances and obstacles


We are about to conclude the baseline research (WP1 Mapping the current capacities of the HEIs and of the labour market needs of the Financial Services Industry in Vietnam & Philippines). Despite of the difficulties caused by the Covid - 19 epidemic, Asian partners carried on an interesting fieldwork and documentary researches.

A questionnaire was administered to Philippines and Vietnamese universities and academic stakeholders. Besides that, Finance and **Technology Business actors** were interviewed to point out the labour market perspectives.

Such scoping study will allow mapping evidence of existing Master programmes in Fintech in Vietnam & Philippines to stress the lacks, the most competitive features, and the future trends. Asian and European Universities together with Finance Industry will effectively cooperate to design a competitive and innovative Master in FinTech.



TRUST core aims will be achieved coherently with the priorities identified in the "New EU Consensus on Development" that highlights the role of education, the importance of creating quality jobs promoting the engagement of young people in the economic, social and political life of their societies. TRUST recognizes the essential function of the knowledge triangle which boosts the interaction between research, education and innovation.







Next challenges

As concerns the baseline research, by the end of November 2020, two reports will be published:
