The meeting started at 9.35, Ilaria Reggiani introduced the Agenda:

The technical requirements and software suggested to record the video lessons will be discussed in a next meeting.

The accreditation documents have been delivered by all institutions. The accreditation procedure will start when the curriculum will be finalised.

WP6 - TRUST Project Digital Information and Dissemination Plan

Due to Philippines association time restrictions, the Presentation of the new dissemination strategy was anticipated at the beginning. The TRUST Project Digital Information and Dissemination Plan has been introduced to all partners. Next steps have been specified as

- TRUST Project to confirm or revise/clarify target audience, key messages
- Partners to assign communications point person
- To facilitate communication, group chats to be created (Viber and/or Facebook messenger groups) "big group" and sub-groups (comms, course development, ManCom etc.)

WP2 Development & accreditation of the Master in FinTech and the modernised masters of Business & Economics

Before starting the presentations, Ilaria Reggiani, on behalf of USGM, specified that as concerns the Fintech Master Curriculum's developments, Prof. Gennaro gathered and processed all the contributions coming from the Asian Universities. It was very hard work since still some partners were more focused on their educational offers and traditional perspectives. It was still impossible to achieve an identical Curriculum, suitable for the Asian HEIs (there were still differences in the Courses List, learning modality, number of hours). At this stage we should overcome the differences and confirm a final list of the foundation/Core Modules, the essential part of the Master and define this structure as TRUST 'basic' Curriculum. We should focus on the design and development of the "online" lessons of the TRUST Master. We need to identify a *Leading Institution* for each course/module that will care of the design and record of the online lessons included. The leading institution will deepen the **syllabus** for the course it is in charge of. The Companies could be invited in online seminars/workshop. Each core/foundation modules/courses will have a minimum number of online lessons recorded (i.e. 15 hours).

The European HEIs met online in the previous day of the meeting in order to tackle with the issue. GCU suggested to focus on the **learning outcomes** (not on the specific courses) of the Master since they will allow us to achieve the harmonisation of the differences.

Thomas Peschken, on behalf of GCU, introduced the definition/previous experience related to the learning outcomes and the TRUST Master specific ones. He introduced the document around the learning outcomes approach with reference to benchmarking, the learning outcomes and the core module descriptions from Prof. Alessandro Gennaro's spreadsheet.
